



Booth Details:

A 10' x 10' booth space with 8' high pipe & drape at rear and 3' high pipe & drape on both sides of the booth. One 6' x 2' skirted table and two chairs.

Terms & Conditions:

Deadline for on-line registration is May 21st and by mail May 16th, 2012.

Registration forms received without payment will not be processed.

Loading docks will be open for unloading on Friday, May 25th from 4:00pm to 8:00pm & Saturday, May 26th from 8:00am to 12:00pm. Vendors must obtain badges from the vendor registration desk, located near the loading dock entrance.

Vendors must wear badges at all times. **Vendors without badges will not be allowed in the bazaar area.**

Bazaar timings are: **Saturday 12:30 pm to 11:00 pm, Sunday 10:00am to 11:00pm and Monday 10:00 am to 3:00 pm.** Bazaar will close for business at prayer times.

Vendors must wear Islamic attires at all times at the convention.

All items displayed or sold in the bazaar must meet Islamic standards.

Sale of food, snacks, or beverages is not allowed in the bazaar area.

All vendors must confine their activities within their respective booths and should not obstruct neighboring booths.

Vendors are not allowed to solicit outside of the assigned booth area.

Vendors using audio/visual equipment must keep the volume low & acceptable to neighboring vendors.

Booths must be kept clean at all times.

ICNA is not responsible for any theft, damage, injury or any loss during the convention. It is the sole responsibility of the vendor to obtain insurance coverage for their business.

Vendors will be responsible for any damage caused by them to the booth or any other property of the Convention Center.

ICNA reserves the right to remove any vendor involved in un-Islamic activity, selling or distributing anti-Islamic literature or pirated items.

Booths located in rows 100, 200 and odd number booths from 301 to 319 are designated for books, jewelry, gifts etc. Any booth(s) reserved for vendors selling clothes will be cancelled and relocated in other row.

Cancellation Policy:

A fee of \$50 per booth will apply if booths are canceled on or before March 31st, 2012.

A 50% refund will be issued for cancellation received between **April 1st and April 22nd, 2012.**

No refund will be issued for cancellations received after **April 23rd, 2012.**

All cancellation must be received by the dates specified above. Cancellations received by phone will not be accepted.
