Liability Waiver:

I agree and consent to this liability waiver.

By registering to attend the ICNA Convention and by physically attending them, I acknowledge, understand and accept the risk of possible exposure to the coronavirus (COVID-19). I understand that while ICNA is taking reasonable precautions to minimize the risk of such exposure to attendees, such precautionary measures are not perfect and any activity involving multiple individuals during this pandemic presents a risk of infection. In consideration for receiving permission to attend the convention, I hereby release, waive, discharge ICNA and its employees, agents, and representatives, and their successors or assignees, from any and all liability, claims, demands, actions, and causes of action of any kind arising out of or related to any actual or suspected exposure to COVID-19, or my participation in the event.

I am consenting to this waiver freely and voluntarily.

Terms & Conditions:

1. Cleaning of the booth area is the sole responsibility of the vendor, and after moving out, all vendors make sure there is no garbage/trash left behind; otherwise, bazaar management will charge you.
2. Vendors must wear badges at all times. Vendors must have badges to be allowed in the bazaar area.
3. Vendors must wear Islamic attire at all times at the convention.
4. All items displayed or sold in the bazaar must meet Islamic standards.
5. Vendors cannot sell food, snacks, or beverages in the bazaar area.
6. ICNA has the right to cancel and remove a booth where a vendor promotes a message that contradicts Islamic Teachings as approved by the ICNA Council of Sharia.
7. All vendors must confine their activities and displays within their respective booths and not obstruct the view or access to neighboring displays/booths.
8. All vendors (for-profit or non-profit) cannot solicit outside their assigned booth area.
9. Vendors cannot move from their assigned booth to another booth, take additional booth space, or move tables, chairs, drapes, or poles from other booths.
10. Vendors are not allowed to have more than 3 feet of banner or hoarding on top of the booth or any curtain or banner which blocks other surrounding booths; ICNA Bazaar management has the right to remove any such thing from the booths.
11. Vendors using audio/visual equipment must keep the volume low & acceptable to neighboring vendors.
12. Booths must be kept clean at all times.
13. ICNA is not responsible for any theft, damage, injury, or loss during the convention. The vendor's sole responsibility is to obtain insurance coverage for their business.
14. Vendors will be responsible for any damage caused by them to the booth or any other property of the Convention Center.

15. ICNA reserves the right to remove any vendor involved in un-Islamic activity, selling or distributing anti-Islamic or pirated items.
16. If the card payment did not go through or the card was declined, the system automatically cancels your booth(s) reservation.
17. ICNA reserved the right to reassign booth(s) of the same category to any vendor.
18. Vendors must arrange their own parking Convention Center, and ICNA will not provide parking.

Cancellation Policy:

1. A cancellation fee of \$50 per booth will be charged and deducted from the refund amount within 72 hours of booking.
2. After 72 hours of a booking cancellation fee of \$400 per booth will be charged and deducted from the refund amount.
3. No verbal or phone call cancellation or changes – if you want to cancel your booth or would like to change, please send an email to bazaar@conv.icna.org
4. A cancellation fee of 50% will be charged and deducted from the refund amount for all cancellations received between sixty (60) and thirty (30) days before the convention start date.
5. No refund for cancellation or change requests received less than thirty (30) days from the convention start date.
